## VI. PRESENTERS:

1. Lucinda Bitsoi: Tohatchi Middle School Principal – I've worked as a high school teacher, but for the past 5 years I have been the Principal at Tohatchi Middle School. I have been with GMCS for 36 years. I would like to share some information on our school and what is taking place currently with our data, growth proficiency, attendance, discipline, activities, and our Mesa testing. We've completed the testing for the beginning of the year and the middle of the year. We are getting ready for our 2<sup>nd</sup> semester testing and will be sharing testing dates.

Courses that are offered at Tohatchi Middle School are Math, ELA (English), Social Studies, Financial literacy, Science, Computer class, PE (Health Class), and Pathways (PLTW) which is more career oriented. We also have Science Technology and Energy Environment; Computer Science for Innovators and Green Architecture and we also have Navajo Language and Special Education. We have an enrollment of 124 students with only have 7<sup>th</sup> and 8<sup>th</sup> graders. Previously, we had 6<sup>th</sup> graders as well, but they are now at the elementary school. We had 9 teachers, but since our enrollment has dropped, we have lost teachers. Other school employees are secretaries, counselors, nurse assistant, custodians, and our cooks. Next, I'll talk little about our MESA (NM Measures of Students & Achievement) which is our state test which is given in April/May and we don't receive the scores until October. Last year assessments for the state test includes English, ELA testing, and Math. For the ELA, I included our 6<sup>th</sup> graders who are now 7<sup>th</sup> graders. We had 23.8% of our 6<sup>th</sup> graders and 28.6% of our 7<sup>th</sup> graders and 49.3% of our 8<sup>th</sup> graders. Looking at the overall proficient of all the grades it's an increase of 34.7%. We celebrate each small growth steps. From the previous school year we had an increase of 7.6% of growth of the previous year to now. For Math, it is 16.4% overall for 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> graders. Our 6<sup>th</sup> graders are at 25.4%, 7<sup>th</sup> graders is 21.4%, and 8<sup>th</sup> graders is at 15.5%. We also have our NM Science test which is called ASR and our in-person students, 39% of our 8<sup>th</sup> graders were proficient from the testing which is a 13.2% growth for school year 2024-2025. We say in-person because included in our enrollment which is not a part of the 124-student enrolled. We have students who do on-line classes, they don't attend school but they are on-line in a different entity and they take their classes there, but they are included.

So, 27.3% of 8<sup>th</sup> graders are proficient and again that's just 13.2% of growth from school year 2024-2025. We are seeing some increases each year and I've been here for the past 5 years. My first year our scores were very low and I had to work with the students and the teachers to make sure we were progressing. Out of the 7 schools in the district, Tohatchi Middle School was 2<sup>nd</sup> in overall growth proficient for the State testing in our Gallup McKinley County School District. First, was Thoreau Middle School and I told the students we want to beat Thoreau. We also sharing the results from the testing with the students so they are aware of where they are at. So, we came in 2<sup>nd</sup> and Crownpoint Middle School came in 3<sup>rd</sup>. So, I'm happy about that. Back in 2023, we were in 3<sup>rd</sup> place overall but we have move up in our growth. Some of the contributing factors that made this growth possible for our students' success is we integrated reading across all content areas. Even though they were in PE class, the teacher would give them something to read like an article. Also, are ELA in math at the beginning of class which we call bell work the students are given some Math or Science questions to answer. The teacher would use an aggressive monitoring tool and they would have the students read to the teacher to make sure they are comprehending the vocabulary being used. We also hold the students accountable as well. We want to instill high expectations for our students. We hold our PDs with staff to go over the continuous data review so they know how well their students are doing or not doing. All this is also shared with their students and also the parents during parent/teacher conferences. As an administrator, I have to hold the teachers accountable as well and I will do classroom walk-throughs where I'll walk into a class unexpectedly to do observations.

**Lucinda Bitsoi** – I mentioned what our contributing factors are and it's moved our students' growth up. We also have board scholars who are students who scored advanced in either ELA Math or ELA. We had 14 of our 6<sup>th</sup> and 7<sup>th</sup> graders and eight 8<sup>th</sup> graders who were there last year so all together there were 22 students who received plaques from Tohatchi Middle School. They do this every year for the middle and high school.

MESA (Measure of Student Success & Achievement) assessments are given at the beginning of the year, middle of year which was in December. We look at students who may need support and we have near target in which a student is near there, but may need a little more support. We have students who are on target which means they are there. Some students go from near target to on target at the end of the year which we like to see. So, looking at our MESA reading scores the 7<sup>th</sup> graders are at 40% who need support, 44% were near target, and 16% were on target. In the middle of the year, 26% need support which was a decrease from the beginning of the year. Near target was 48%, and we kind of even out on the students who were on target 26% which means went from 16% to 26% at the middle of the year making some improvements. With our 8<sup>th</sup> graders, there were no changes at 54% who needed support. Near target at 20% at beginning of the year and 25% at the middle of the year with a little increase there and 27% on target and that 21% went down. This is for reading and language usage, for 7<sup>th</sup> graders again needed support at the beginning of the year which was a decrease and a lot of them went to near target at the middle of the year which was an increase. With our 8<sup>th</sup> graders, we had 31% that were need support and 60% at near target but that changed in the middle of the year with 14% needs support and increase from 9% to 32% for on target. For Math, 7<sup>th</sup> graders 43% to 30% we had a little increase from 52-59% near target and 5% on target. It moved up a little, 11% for 7<sup>th</sup> graders, but we are hoping to see an increase at the end of the year. For 8<sup>th</sup> graders, we had 73% who needed support then it changed at the middle of the school year to 37%. Near target 21% went up to 42%, so some of the students moved up to near target and our 5% moved up to 20%. So, we are making some gains there which we like to see. Our testing is coming in the spring and that's all we will be concentrating on.

Attendance: On average our attendance is 94-97% for today which I check daily and of course it

fluctuates. One day we had all our student here except for one student and the next day we have 13 students absent. Even when the student is checked out, it counts as an absent and the student is only allowed and this is through the state and the district 18 absents for the whole year. So, if they go over the 18 absents that puts us in the chronic absenteeism. We always tried to emphasize to our students and parents that they need to be in school every day. From August to December, we've had 7 major near discipline incidents that resulted in suspensions and it varies. I can say two out of the seven were the same students. Our minor incidents will vary and since coming back from break we have not had an incident. The minor incident will have a verbal warning or maybe a parent contact or sometimes it's a suspension depending on the incident. It is important to have the parents or guardian discipline their child at home and at school. Every quarter we have family nights which has to tie in with what our students are learning, math, reading, science, social studies, and cultural night. We try to schedule these events when nothing else is going on in the community. These family nights include the teachers and they have to have some type of activity for the student and the parent. Our school sports are cross country, football, volleyball for fall, and boys' and girls' basketball are happening right now and baseball, softball, and track for springs. The clubs we provide are art club, bike club, student council, MESA for our science students, yearbook, and MJHS and TSA which are our native club. We have upcoming testing in February for our ELL students which test their reading, writing, listening, and speaking skills. Our school was chosen along with one of the elementary, David Skeets. We are the only schools who will be taking this NAPE test and it is just random they choose schools through the government and they are only testing 50 8<sup>th</sup> graders and this is scheduled for March 10<sup>th</sup>. We also have our boot camp scheduled for March as well. We do a lot of activities with the students to prepare them for testing. In April, we will be having our 8<sup>th</sup> grade science testing and state testing. Then in May we will be having our end of the year MESA. We do offer after school tutoring on Tuesday, Wednesday and Thursday. And just to add, our students are doing good things at Tohatchi Middle School. Thank you.

**Laris Manuelito** – You mentioned the smart kids get bored; do they have a gifted program that would challenge them? The learning style of a gifted child is very different.

**Lucinda Bitsoi** – We do have a gifted program and we have only one teacher from GMCS who comes out for this program. The gifted teacher goes to Navajo, Tohatchi, Chee Dodge, and Twin Lakes and just having one person to cover all these school makes it very difficult to get these students to be challenged a little bit more. Our 8<sup>th</sup> graders will attend the academy at UNM Gallup. A lot of these students like to be challenged.

**Laris Manuelito** – Are there challenges that face the gift program for them to be able to go into McKinley Academy and the other charter school? I don't know how Academy works.

**Lucinda Bitsoi** – the student will go through a process; they look at test scores and they do interviews.

**Laris Manuelito** – Is the school considering bringing back music classes? Is there anything from the chapter/community that would help advocate for those programs back?

**Lucinda Bitsoi** – that would be awesome and I even tried bringing in art classes because a lot of our students are very creative, but the 1<sup>st</sup> thing they look at is enrollment. As far as what the chapter/community can do is probably voice those with the District school board members.

**Laberta Etsitty**: Navajo Nation Pre-School Instructor – No show.

**Julia Thompson** – I would like to ask if the PEP position is being advertised because it seems like the same

individuals are working. I just feel other people may need jobs and also, we have elders in the community who need assistance. I made 3-4 calls to the chapter requesting for help and I was told it has to be a written in black and white. What if the person can't make it to the chapter to fill out a request form? I think there should be new workers who are willing to help the elders.

**President Bitsilly** – These positions should be advertised and we have gone through this topic with the staff. I understand what you are saying, PEP workers are only hire for a certain duration of time to get some training. On that particular day in question, I understand the PEP workers were already working on another project that day and they could not drop what they were working on to assist. The reason a request for assistance has to be completed on a form (Work Order) that the chapter provides is to cover the Chapter for any liability and insurance.

**Laris Manuelito** – I don't know if there is a re-evaluation of the high risk and disable individuals that need to be visited. Perhaps she can be put on there or a regular visit to them to make sure they are ok.

Also, I recommend the word April be strike and changed to May to match the resolution.

**Secretary/Treasurer Crawford** – Maria, CSC states it should read April 2026.

**President Bitsilly** – The Chapter does have the names of individuals in our community who are considered high risk. We currently do not have a CHR but are sharing a CHR with Mexican Springs and Twin Lakes.

6. **017-01-2026:** Resolution to approve the Capital Improvement Projects (CIP) plan for year 2027-2031. The 3 projects include: Tohatchi Public Safety Complex, Warehouse, and Highway 491 Lighting Project.

**Vice President Rodgers** – regarding the Safety Complex, we should be done with the design and I've pushing it to make it 100% because we need to prove we are done with this phase. We are ready for construction. The warehouse design is also completed, just need the fund for construction. The highway lighting has several parts to that and most of the work is being done by NN Department of Transportation. We are ready for the plans and design for this project.

**Laris Manuelito** – For the Public Safety Building, is there a possibility to reinstate sheriff and NM State Police Departments along with the Navajo Nation because you can get funding from them as well. This is my 3<sup>rd</sup> recommendation.

**President Bitsilly** – We are working to re-initiate that possibility with sheriff, county, and state. I hear Navajo Nation is not to thrill about that because they will be owning the building. We received \$4 million from TIF (Tribal Infrastructure Fund). We are dealing with NM funds but we are not allowing NM safety

entities to be involved here at the local level. The original name for the building was Public Safety Complex but has since been changed to First Responder Substation because the Navajo Nation has it listed as such. So, we need \$12 million for this project. We did apply for fund through Capital Outlay and we may request for more funding from TIF. We are allowed to apply for multiple projects and its my understanding we are not allowed to apply for TIF if we have already received funding from them and we will look into this. We are also asking Delegate Notah to help lobby for funds from the NN from Sihasin funds and the governor's portal as well.


